Course description: This course is designed to explore the interactions between humans and the environment, including our associations with climate, food and fiber production, water supply, and forest resources. Understanding these natural systems and the physical and social causes of adverse impacts will enable students to recognize our ecological footprint as well as develop strategies to mitigate these critical environmental problems.

Learning objectives:

- Demonstrate an understanding of the complex environmental problems facing the global community in the 21st century.
- Evaluate potential sustainable solutions to mitigate environmental problems.
- Identify sustainable management tools for natural resource management systems.
- Engage in meaningful discussion on global environmental issues with fellow students.

Global Learning Outcomes and Assessments:

- 1. Global Awareness: students will be able to demonstrate an understanding of the scientific information and key concepts that underlie the functioning of natural systems with an emphasis on the interrelatedness of these systems with each other and human societies, as well as the negative impacts of environmental degradation on both.
- **2. Global Perspective:** students will be able to examine environmental issues with a multiperspective framework that supports creative ideas to promote environmental sustainability
- **3. Global Engagement:** students will demonstrate a willingness to reflect on their own relationship to the environment and take responsibility to reduce their own ecological footprint as well as engaging in local, global and intercultural environmental problem solving.

Global Learning Graduation Honors:

FIU's Excellence in Global Learning Graduation Medallion is awarded to students who complete at least four global learning courses, participate in a variety of global co-curricular activities, and complete a capstone consisting of one of the following: a substantial original research project and presentation on a global topic; extensive foreign language study; long- term study abroad; or, a globally-focused internship. The Peace Corps Prep certification is conferred upon students who complete at least four global learning courses, extensive language study, and a global problem solving project. Course Requirements:

- 1. Group quizzes (breaking into groups of 8-9 students) will be held every day at the end of class. The top 15 quiz grades will be counted towards your final grade.
- 2. Students will be expected to participate in the class blog on Canvas. The blog should reflect students' opinions on the class readings as well as commentaries from other students. I expect that students will participate in at least 10-15 Chapter blogs in order to receive full credit (counts towards participation grade).
- 3. Students will volunteer for a community service project related to the class (e.g., beach cleanup, community garden workday, exotic plant removal) and write a short summary (1 page, single-spaced) on observations made during the activity. I will also require proof of participation (a form to be signed by project manager, available in Canvas). Summaries will be uploaded to Canvas; signed participation forms will be returned to me in class.
- 4. Students shall select an environmental documentary to review (e.g., *Before the Storm*) outside of class. The film should be 1-2 hours in length. After watching the video, students will hand in a review/summary of the film (approximately 3 pages, single-spaced). Reviews will be uploaded to your Canvas account.
- 5. If students attend 3 seminar/presentations (appropriate to class content) and fill out the seminar summary template (see pg. 8 of this syllabus), they will receive 5% extra credit.

Disciplinary sanctions:

- 1. expulsion, including record on transcript.
- 2. suspension, including record on transcript.
- 3. disciplinary probation
- 4. failing or reduction of grade
- 5. restitution or reimbursement for damages
- 6. restriction of university privileges
- 7. service to the university
- 8. counseling
- 9. enrolling in a specified course
- 10. other

Procedures

- 1. referral through the vice provost
- 2. charges brought by faculty member, student, or even person outside the university
- 3. complainant must meet with suspected student first
- 4. student's status unchanged pending the outcome of investigation
- 5. informal resolution: completed within 14 days of event; complainant discusses event with vice provost first
- 6. formal resolution: referred directly to vice provost; student hears from this office within 7 calendar days of submission of information
- 7. student informed in writing
- 8. university academic conduct review board hearing: one grad faculty, one administrator, two grad students
- 9. university academic conduct review board finds student responsible or not responsible based on a preponderance of evidence; chair votes to break ties
- 10. vice provost: choice to accept recommendation or remand the case for a rehearing
- 11. student has right to appeal; done within 14 days of decision notification
