

Overview

The Spotlight on Education competition offers students a unique opportunity to engage with highly skilled educational professionals who specialize in subjects beyond the core curriculum. The competition aims to highlight the invaluable contributions of instructional-support specialists in shaping students' lives. These specialists encompass a diverse range of roles, including:

- Special Education Teacher
- Speech Pathologist
- School Psychologist
- Occupational Therapist
- School Administrator

- School Counselor
- School Social Worker
- Librarian
- Non-core subject teacher
- Curriculum specialist

Participants will select one specialized instructional support specialist to shadow and conduct an interview with. Each student will obtain permission to shadow the professional for a total of four (4) hours, which can be accumulated over several days or weeks to observe the specialist in their active work environment.

Competitors are required to complete and submit two career exploration documents by the deadline, which are available on FIU's FEA Regional Conference website.

- A. Host educator's verification form
- B. Interview form

Students participating in this competition will create a tri-fold poster display showcasing their research on the chosen profession and detailing their insights gathered from the job shadowing and interview experiences. Poster sessions, like those held at professional conferences, will allow judges and fellow participants to review these displays during breakout sessions I and II. Each competitor must be present and stand by their poster to discuss their findings and answer questions.

Participation Details

- This is an individual competition.
- Up to two (2) entries per chapter will be accepted. Each chapter must select one or two students to represent them.
- A maximum of twenty-four (24) entries in total will be accepted, on a first-come, first-served basis.



Competition Guidelines

- A. The shadowing experience must be for a total of 4 hours.
- B. The competitor must interview the host educator. Both the completed Host Educator's Verification Form and Interview Form must be brought to the conference and placed next to the competitor's tri-fold poster display.
- C. Judges will review both forms during the competition as they circulate among the displays. It is the competitor's responsibility to ensure that the forms are visible and available for review. Forms that are not present at the time of the judging will not be considered.
- D. Students will create a display that reflects the job-shadowing experience, career research, interview with the educator, and their insight into a career in the educator's field.
- E. Display boards should be a standard threepanel display board that unfolds to be 36" tall by 48" wide and include:

- 1. Summary of the professional's duties and responsibilities.
- 2. A description of a typical day at the educator's job.
- 3. Training and education required for the job, and where you can obtain them.
- 4. Classes that teach the skills necessary for the job.
- 5. Your thoughts on the professional's duties and responsibilities.
- Your thoughts on whether this may be a career you consider for yourself in the future.
- 7. Photos are optional.
- F. Students should be prepared to answer questions and have a discussion with the on-site judges.
- G. All display boards must be removed from the competition room before the closing session.

Judging and Scoring

- A. Competitors must be present at the scheduled time; otherwise, they will be disqualified.
- B. The judges' decision is final.
- C. Competitors agree to be bound by the FEA General Competition Rules.
- D. The entry will be scored using the Spotlight on Education Competition rubric.

How to Enter

- A. Up to two (2) entries per chapter will be accepted. Each chapter must select one or two students to represent them.
- B. All entries for individual and/or chapter competitions must be submitted by the chapter's sponsoring teacher via the Online Competition Entry Form by 5:00 pm on Friday, October 31, 2025.
- C. Entries submitted by email will not be accepted.
