Florida International University Department of Psychology Undergraduate Applied Behavior Analysis Track Course Sequence

The course sequence below meets the instructional content requirements of the Behavior Analyst Certification Board © (BACB) **6th Edition Test Content Outline (TCO)**. The courses are open to all students, regardless of major or degree-seeking status. All are usually offered every semester on campus and online, and instructional modalities may be combined. Students who intend to become a Board Certified Assistant Behavior Analysts are urged to read the eligibility requirements and certification process detailed in the <u>BACB BCaBA Handbook</u>. Psychology majors who wish to have Applied Behavior Analysis noted as an area of specialization on their transcript should contact their academic advisor to add the <u>ABA Track</u> to their plan of study.

RECOMMENDED SCHEDULE: The course sequence will take a **minimum** of 4 semesters to complete and should be taken as shown below. Not taking the sequence as indicated below may result in extending it beyond 4 semesters due to course prerequisites. Students admitted to FIU as freshman should begin the sequence in their sophomore year, and transfer students should begin the sequence in their first semester.

EAB 3002 Introduction to the Experimental Analysis of Behavior (3 credits)

Prerequisite: PSY 2012

Note: Does not meet the 6th Ed. TCO standards if taken prior to fall 2024.

EAB 3794 Principles of Applied Behavior Analysis (3 credits)

Prerequisite: EAB 3002

Note: Does not meet the 6th Ed. TCO standards if taken prior to spring 2025. May be taken with EAB 4782.

EAB 4782 Ethics in Applied Behavior Analysis (3 credits)

Prerequisite: EAB 3002

Note: May be taken with EAB 3794.

EAB 4764 Advanced Principles of Applied Behavior Analysis (3 credits)

Prerequisites: EAB 3794 and EAB 4782

Note: Does not meet the 6th Ed. TCO standards if taken prior to summer 2025. May be taken with EAB 4798.

EAB 4798 Single Case Research Methods (3 credits)

Prerequisites: EAB 3002

Note: Does not meet the 6th Ed. TCO standards if taken prior to summer 2025. May be taken with EAB 4764.

EAB 4741 Supervision in Applied Behavior Analysis (3 credits)

Prerequisites: EAB 4798 and enrollment in the ABA track.

Note: May be taken concurrently with EAB 4795.

EAB 4795 Senior Seminar in Applied Behavior Analysis (3 credits)

Prerequisites: PSY 3213 or PSY 3215, AND EAB 4764

Note: Does not meet the 6th Edition TCO standards if taken prior to fall 2025. Does not include content that is required for certification but is <u>required for completion of the track</u>. May be taken concurrently with EAB 4741. Includes BCaBA certification exam and career preparation. PSY 3213 and/or PSY 3215 may be waived, <u>at</u> the discretion of the instructor, for non-psychology majors and non-degree-seeking students ONLY.

Prerequisites may not be waived for degree-seeking psychology majors.

Course substitutions are NOT allowed.
