

BCaBA PATHWAY 2 COURSEWORK ATTESTATION INSTRUCTIONS

The FIU undergraduate behavior analysis course sequence meets the coursework requirements to sit for the BCaBA exam under Pathway 2. The Behavior Analyst Certification Board (BACB) requires a BCaBA Pathway 2 Coursework Attestation as part of the exam application documents. Please follow the process and instructions below to obtain an attestation. The BCBA is currently accepting coursework under the 5th Edition Task List and the 6th Edition Test Content Outline. The courses for each edition are listed below.

Note: Courses taken before spring 2021 cannot be used toward certification. The 5th edition courses will be valid until December 31, 2026 ONLY. **Coursework from the 5th and 6th editions cannot be combined.** The BACB requires a minimum grade of C in each course.

PROCESS

1. **All courses must be completed and grades posted. Attestations with pending grades will not be accepted.**
2. Create an account at www.bacb.com to obtain a BACB ID number.
3. Complete the BCaBA Pathway 2 Coursework Attestation form following the instructions on the form and below.
4. Send the completed attestation form and a copy of your unofficial transcripts to mcigales@fiu.edu.
Write 'BCaBA Attestation' followed by your Panther ID in the subject line. For example: BCaBA Attestation 1234567
5. The attestation form will be reviewed for completeness and correctness.
6. If changes are needed, it will be sent back to you with specific feedback. **This will delay the process.**
7. If no changes are needed, it will be signed, dated and submitted to the BACB. You will be notified.
8. Processing time can be up to two weeks. Please do not inquire about the status of your request if it has been less than two weeks since you sent it.

INSTRUCTIONS FOR THE BCaBA ATTESTATION:

1. Use the BCaBA Pathway 2 Coursework Attestation (linked below).
2. Fill in all blanks except for the Pathway 2 Program Contact Signature and signature Date at the bottom.
3. The 'Date of First Qualifying Behavior-Analytic Course' is the first date (month, day and year) of attendance in the first EAB course passed with a C or higher (usually EAB 3002).
4. List the EAB courses you completed with a C or higher. The 5th edition and 6th Edition courses are listed below. Do not list any other courses.
5. List the courses in the order in which they appear on your transcript.
6. The 'Institution Name' is Florida International University.
7. The Course Level is 'Undergraduate'.
8. Include the course prefix (EAB) with the Course Number.
9. Write the Course Name as it appears on your transcript.
10. Enter Maricel Cigales in the blank after "By signing below, I,..."
11. Enter your name in the blank beside 'APPLICATN Name'
12. The 'Pathway 2 Program Contact Name' is Maricel Cigales
13. The 'BACB ID or Certification Number' is 1-00-0250
14. Send the completed attestation as an **editable PDF** attachment and your unofficial transcript to mcigales@fiu.edu.
15. Be sure to put "BCaBA Attestation" followed by your Panther ID number in the subject line.

EAB 3002 completed between Spring 2021 and Summer 2024
EAB 3794 completed between Summer 2021 and Fall 2024
EAB 4764 completed between Summer 2021 and Spring 2025
EAB 4798 completed between Fall 2021 and Summer 2025
EAB 4795 (or PSY 4931, ABA only) completed between Fall 2021 and Summer 2025

Courses under each edition must have been completed within the semester ranges indicated.

EAB 3002 completed Fall 2024 or after
EAB 3794 completed Spring 2025 or after
EAB 4782 completed Spring 2025 or after
EAB 4764 completed Summer 2025 or after
EAB 4798 completed Summer 2025 or after
EAB 4741 completed Fall 2025 or after

EAB 4795 is not part of the 6th edition course sequence. Do not list it on the attestation form.
